I INTRODUCTION

1. C.H.Mohammed Koya Memorial State Institute for the Mentally Challenged is an autonomous body under the General Education Department Government of Kerala. The main objective of the institute is to co-ordinate and promote education, training and rehabilitation of the mentally challenged persons in the State. The diploma programme in teaching the mentally challenged children is an under graduate level course recognized by the Rehabilitation Council of India (RCI) and its main aim is to implement educational programmes to promote the integration of mentally challenged persons in the community.

II COURSE

The duration of the diploma course is 2 years 2016-2018.220 working days for each year. The total hours for the theory and practical teaching will be 1320 hours in a year and 2640 hours in two years. The curriculum of training will consist of theory and practical classes.

III. No of seats.

1. Total No. of seats for the course will be 25.

IV. Eligibility

1. Minimum educational requirement for admission to this course should have minimum 50% marks in the qualifying examination (i.e plus two or its equivalent) with relaxation of marks and reservation of seats as per the instructions of the Government. Candidates belong to SC/ST category will be eligible for reservation as per rules.

V. Application Forms.

1. The prescribed application form and prospectus can be obtained from the Principal, State Institute for the Mentally Challenged Pangappara, Thiruvananthapuram-695581, on request with self addressed Rs.25 stamped envelope of size 30X15cm by post till 20-05-2016 OR downloaded from the website www.simctvm.in. Application forms will be issued at a cost of Rs. 100/- per form, which may be paid in cash or demand draft in favour of the Principal.

VI. Submission of Application.

1. Application duly filled and with the following self attested certificate should reach the Principal on or before 20-05-2016 .Late application will be summarily rejected.
2. Photocopy of mark list of qualifying examinations.
3. Photocopy of degree certificate if any.
4. Applications send by post should be registered with acknowledgement due. Applications may be submitted in person at the institute.
5. Applications received after due date and those not accompanied by required documents/details will not be considered candidates are advised not to enclose originals of any documents.

VII. MODE OF SELECTION

1. Selection will be made on the basis of marks on qualifying examinations
2. Candidates must produce originals of all documents at the time of the interview. Those who fail to produce the originals at the time of interview will not be considered for admission.

IX. Teaching Staff

The core staff comprises faculty members in the field of Special education, and Psychology, supported by the regular and guest lectures in the field of Medical Science, Speech Pathology& Audiology, Physiotherapy, Social work and related disciplines.

X. EXAMINATIONS

The admitted candidates will be evaluated continuously through out the academic year.

There will be mid-term examinations. The final examinations would be conducted by Rehabilitation Council of India. 80% of attendance is compulsory to be eligible for appearing in the final examinations.

XI. **ISSUE OF DIPLOMA**

Successful candidates will be awarded a Diploma by RCI.

XII. 1. If any information given in the application is found to be false on verification at the time of

Interview or even at later state the candidate will forfeit his/her claim for admission.

2. Candidates call for the interview should report at the specified time with the originals of all documents. No change of date, time or venue of interview will be allowed under any circumstances on demand of the candidate.
3. No.T.A will be given for attending the interview.
4. All candidates will have to be abide by the rules & regulations issued from time to time by the Institute. General discipline must be strictly followed.
5. The council will decide any other details not specifically covered by these Clauses and such decisions shall be final.
