I. INTRODUCTION

C.H.Mohammed Koya Memorial State Institute for the Mentally Challenged is an autonomous body under the General Education Department Government of Kerala. The main objective of the institute is to co-ordinate and promote education, training and rehabilitation of the mentally challenged persons in the State. The diploma programme in teaching the mentally challenged children is an under graduate level course recognized by the Rehabilitation Council of India (RCI) and its main aim is to implement educational programmes to promote the integration of mentally challenged persons in the community.

II. COURSE

The duration of the programme will be 2 years (4 semesters). On completion of four semester the total theory would be 900 hours and practical would be 1500 hours.

III. No of seats

Total No. of seats for the course will be maximum 35.

IV. Eligibility

Minimum educational requirement for admission to this course should have minimum 50% marks in any stream in the qualifying examination (i.e plus two or its equivalent) with relaxation of marks and reservation of seats as per the instructions of the Government. Candidates belong to SC/ST category will be eligible for reservation as per rules.

V. Application Forms

The application form and prospectus can be obtained direct from the institution or downloaded from the website www.tvmsimc.in. Application forms will be issued at a cost of Rs. 200/- per form, which may be paid in cash or demand draft in favour of the Director SIMC, payable at State Bank of India, Sreekaryam Branch, TVM, IFSC Code-SBIN0006686.

VI. Submission of Application

Application duly filled with the following self attested certificates should reach the Director SIMC, Pangappara, Thiruvananthapuram, Pin-695 581 on or before 07/06/2024. Late application will be summarily rejected.

1. Photocopy of mark list of qualifying examinations.
2. Photocopy of degree certificate if any
3. Photo should be paste in the application form in the prescribed size (35 x 45 mm)
4. Applications send by post should be registered with acknowledgment due. Applications may be submitted in person at the institute.
5. Applications received after due date and those not accompanied by required documents/details will not be considered, candidates are advised not to enclose originals of any documents.

VII. MODE OF SELECTION

1. Selection will be made on the basis of marks on qualifying examinations and interview.
2. Candidates must produce originals of all documents at the time of the interview. Those who fail to produce the originals at the time of interview will not be considered for admission.

VIII. Fees

Tuition Fee	RS.12,000/-(for two years)
Caution Deposit	Rs. 1,000/-(Refundable)
Examination Fees	As specified by the examination agency entrusted by the RCI.

IX. Teaching Staff

The core staff comprises faculty members in the field of Special education and Psychology, supported by the regular and guest lectures in the field of Medical Science, Speech Pathology & Audiology, Physiotherapy, Social work and related disciplines.

X. EXAMINATIONS

The admitted candidates will be evaluated continuously through out the academic year. There will be mid-term examinations. The final examinations would be conducted by Rehabilitation Council of India. 80% of attendance is compulsory to be eligible for appearing in the final examinations.

XI. ISSUE OF DIPLOMA

Successful candidates will be awarded a Diploma by RCI.

XII. If any information given in the application is found to be false on verification at the time of Interview or even at later state the candidate will forfeit his/her claim for admission.

1. Candidates called for the interview should report at the specified time with the originals of all documents. No change of date, time or venue of interview will be allowed under any circumstances on demand of the candidate.
2. No.T.A will be given for attending the interview.
3. All candidates will have to abide by the rules & regulations issued from time to time by the Institute. General discipline must be strictly followed.
4. The council will decide any other details not specifically covered by these Clauses and such decisions shall be final.
